OEPA ASBESTOS NOTIFICATION REQUIREMENTS

Under Chapter 3745-20-01(B)(18) of the Ohio Administrative Code a privately owned residential building with four or fewer dwelling units is not considered a regulated facility subject to OEPA Asbestos Notification Requirements, unless part of a larger installation.

Examples of what may be considered part of a larger installation include, but are not limited to:

- Apartments or housing complex.
- Homes demolished under the control of a government entity (urban renewal or public safety project).
- Conversion of a residential dwelling into a commercial structure.
