Board of Health Order Updates

<u>Ashtabula County Board of Health Bylaws Draft – 3rd reading – Prosecutors Opinion</u> Not voted on pending further edits including adding specific policies for Board of Health Members to follow in Section 6C and adding Article 9 (replacing duplicated Article 8)

<u>District Advisory Council (DAC) Special Meeting or Licensing Council appoint Board of Health Member.-Prosecutors Opinion</u>

The Prosecutor believes that the licensing council should appoint a Board of Health Member, but is awaiting confirmation from the state's legal counsel. It was recommended that the Health Department move forward with the DAC Special Meeting to speed up the replacement process instead of continuing to wait on the state.

If the state approves the licensing council to appoint a Board of Health Member, the Health Department could then proceed with the licensing council appointing a Board of Health Member upon the next vacancy.

3 July 12, 2023

Bureau of Workers Compensation (BWC)-New letter received from the Ashtabula County Commissioners.

A motion was made by Duane Marcy and seconded by Bryce Heinbaugh to approve the BWC payment of \$30,000.00 to the Ashtabula County Commissioners.

The board requested that the Health Commissioner, Jay Becker draft a letter to be sent to the County Commissioners highlighting and encouraging lines of communication going forward to prevent a similar situation in the future. Mr. Becker will also let the commissioners know that our staff will be limited in their travels to the County Courthouse to minimize the risk to staff. In the past staff were required to make deliveries and pickup documents from various County Departments 5 days per week but that will be cut back to 3 days per week initially with the goal to eventually be only 2 days per week.

New Business

The board examined solid waste disposal violations pertaining to the property located a 2917 Arthur Rd., Plymouth Township owned by Michelle Conner, 2917 Arthur Rd., Jefferson, Ohio 44047.

Inspections of the property revealed the presence of bags of trash and a large amount of solid waste including plastic waste materials, discarded household items, tires, plus multiple vehicles on the property. Witnesses have also seen rats. The improper disposal of solid waste is a public health nuisance and violates Ohio Solid Waste Disposal Regulations.

The presence of debris and waste on the property will contribute to a rodent infestation and a mosquito public health nuisance. The debris can collect water and allow mosquitoes to breed. Mosquitoes can transmit West Nile Virus and Encephalitis.

In view of these violations, a motion was made by Bryce Heinbaugh and seconded by Duane Marcy, that the Ashtabula County Board of Health order Michelle Connor to: (1) remove and dispose of all solid waste at a licensed landfill by August 4, 2023; (2) Submit receipts from a licensed landfill to confirm proper disposal of solid waste on or by August 4, 2023; (3) submit proof of weekly trash service for this address to the Ashtabula County Health Department by August 4, 2023.

Failure to comply with this order will result in the matter being referred to the Ashtabula County Prosecutor's Office for enforcement action.

The board examined a valid sewage nuisance complaint pertaining to the property located at 1852 St. Rt. 7, Richmond Township, occupied by Larry Lowe and owned by Delorise Brown, 1831 Forest Hills Ste 105, East Cleveland, Ohio 44112.

The home sewage treatment system serving this dwelling has failed and needs to be replaced or repaired.

In view of these violations, a motion was made by Bryce Heinbaugh and seconded by Rebecca Robinson that the Ashtabula County Board of Health order Mr. Lowe and Ms. Brown to: (1) repair or install an approved home sewage treatment system by August 4, 2023; (2) after the septic system is repaired or a new system is installed, contact the Ashtabula County Health Department to have the Environmental Health Specialist inspect the repair or the new system; (3) vacate this property until the system is repaired or an approved home sewage treatment system is installed.

Failure to comply with this order will result in the matter being referred to the Ashtabula County Prosecutor's Office for enforcement action.
