a. The board examined solid waste disposal violations pertaining to the property located at 2757 Pinney Topper Rd., Plymouth Township, owned by Ashley Rose Bickerstaff, 2757 Pinney Topper Rd., Jefferson, OH 44047

An inspection conducted by Matt Menzie, R.E.H.S., on August 23, 2023, confirmed that the solid waste violation has been abated and no further enforcement action is required.

b. The board examined plumbing violations that include the installation of a complete commercial kitchen without approvals and plumbing permits obtained from the Ashtabula County Health Department pertaining to the property located at 1606 Columbus Avenue, Ashtabula City, owned by Robert Stillman, 1020 E. 16th St., Ashtabula, Ohio 44004.

All newly installed plumbing must be inspected by the Ashtabula County Health Department. Local plumbing regulations of the Ashtabula County Health Department require that a plumbing permit must be obtained prior to installing plumbing.

Shawna Pierce, renter, attended the meeting. Ms. Pierce stated that her lease agreement with Mr. Stillman states that Mr. Stillman is responsible for upgrading all plumbing and electrical work for Ms. Pierce to be compliant to run a food establishment. Board member Bryce Heinbaugh recommended that Ms. Pierce obtain legal representation regarding the lease agreement. Christopher Fortunato, Assistant Prosecutor believes that Mr. Stillman is not in compliance with the Ashtabula County Building Department and that the building department should be notified.

A motion was made by Bryce Heinbaugh and seconded by Rebecca Robinson that due to Mr. Stillman's noncompliance with the OAC 4103 and 4101 and Chapter 3 Section 312.12 of the 2017 Ohio Plumbing Code, the Ashtabula County Board of Health order Mr. Stillman to: (1) obtain the proper commercial plumbing permit from the Ashtabula County Health Department by September 18, 2023; (2) Schedule a plumbing inspector from the Ashtabula County Health Department to inspect the plumbing work that has been completed on the property located at 1606 Columbus Avenue, Ashtabula Ohio by September 18, 2023.

Failure to comply with this order will result in the matter being referred to the Ashtabula County Prosecutor's office for legal enforcement of this matter.
