Old Business: Jay Becker, Health Commissioner (Listed in Dropbox)

The Appalachian Grant Project that has been selected by Eastgate for Ashtabula County would create two public school health centers; one at Ashtabula City Schools and one at A-Tech. They are looking for a healthcare organization to provide staffing for these centers. Currently, interested parties include ACMC, UH Hospital and Signature Health. The opportunity was proposed to the Ashtabula County Health Department. If interested, a 10-14 question application is due in November. Topics in the application include how the Ashtabula County Health Department would operate the centers, staffing needs, and how to maintain the centers. Funding would cover startup costs and what would be needed to keep the centers going.

## New Business: Jay Becker, Health Commissioner (Listed in Dropbox)

The board examined a report that occupants of the property located at 3256 Dodgeville Rd., Cherry Valley Township, owned by William & Rita Woodworth, 171 Chestnut St., PO Box 1202, Andover, Ohio 44003 are residing in a camper. The occupants must have approved sewage disposal and approved plumbing and water system to be considered a permanent occupancy. It has been noted that there is no garbage collection at this address.

The occupancy of the camper as a year round dwelling violates a number of home sewage treatment system rules, solid waste disposal rules, plumbing regulations and most likely building code regulations.

Inspections of the property also revealed the presence of trash and a large amount of solid waste strewn throughout the property, on the porch, under the porch, and around the detached garage. The improper disposal of solid waste is a public health nuisance and violates Ohio Solid Waste Disposal Regulations.

The presence of miscellaneous debris and waste will contribute to rodent infestation and a mosquito public health nuisance. Mosquitoes can transmit West Nile Virus and Encephalitis.

A motion was made by Bryce Heinbaugh and seconded by Rebecca Robinson that in view of these violations, the Ashtabula County Board of Health order William & Rita Woodworth to: (1) vacate the camper by November 1, 2023; (2) remove and dispose of all solid waste at a licensed landfill by November 1, 2023; (3) submit receipts from a licensed landfill to confirm proper disposal of solid waste on or by November 1, 2023;

Failure to comply with this order will result in this matter being referred to the Ashtabula County Prosecutor's Office for enforcement action.
