#### **New Business:**

The board examined a solid waste disposal complaint pertaining to the property located at 3176 Lawton St., Rock Creek Village owned by James Thibeault, 625 Knollwood Dr., Ashtabula, Ohio 44004.

Inspections of the property revealed the presence of a significant accumulation of trash, a mattress and miscellaneous solid waste strewn throughout the property. This solid waste must be removed and disposed of in a licensed landfill. The improper disposal of solid waste is a public health nuisance and violates Ohio Solid Waste Disposal Regulations.

A motion was made by Robert Russell and seconded by Duane Marcy that the Board of Health order James Thibeault to: (1) remove and dispose of all solid waste at a licensed landfill by April 4, 2024; (2) submit receipts from a licensed landfill to confirm proper disposal of solid waste on or by April 4, 2024; (3) submit proof that there is weekly trash service for this address to the Ashtabula County Health Department by April 4, 2024.

Failure to comply will result in this matter being referred to the Ashtabula County Prosecutor's Office for enforcement action.
